Rules & Regulations

- 1. The medium of instruction in our school is English and every pupil must speak English in the school campus. Every one should make a serious effort to speak English both inside and outside the class.
- 2. Student Evaluation Profile showing the application of the pupils and their results must be collected by the parents at the time of class PTM. It Must be duly signed and given back to the school.
- 3. No pupil who fails for two years in succession will be kept in the school.
- 4. The school uniform is compulsory on all class days and at school functions. Pupil must come to school neat and tidy.
- 5. Student must be punctual for class, those who have been absent or who come late will be admitted to the class only with the permission of the Principal.
- 6. Student should at all times show respect to the school authorities and the staff. They should be gentle and polite to their companions.
- 7. Students are not allowed to interview parents or visitors or to leave the school premises during school hours without the permission of the Principal.
- 8. Money should not be lent or borrowed or articles exchanged without permission.
- 9. It is forbidden to write or scribble on the walls, desks, throw paper in the class room or in any way damage the school property. Damages caused must be paid for at the discretion of the principal.
- 10. The school is not responsible for the goods lost. It is not advisable to bring valuables like expensive watches, ornaments of gold or any electronic gadgets.
- 11. If anyone brings valuables like Mobile phones, IPod, etc... it will be taken and will not be returned.
- 12. Irregular attendance, habitual idleness, neglect of homework, disobedience and disrespect towards members of the staff or bad moral influence justify dismissal. Pupils are responsible to the school authorities for their conduct both in and outside school
- 13. Attendance at official school functions like youth Festival, Childrens Day, Teachers Day, Independence Day, Republic Day, Annual Day etc...is compulsory.
- 14. Students are strictly forbidden to introduce any sort of comics, objectionable literature in to the school or to purchase any article of good from the unauthorized dealers, from the school premises.
- 15. We take all possible care for the safety of the children. In spite of all the diligent care we take, if any accident happens in the school premises the school will not be responsible for it.
- 16. The school authorities are not responsible for the safety of the pupil after school hours. Necessary arrangement should be made by the parents to take the children home after school hours.
- 17. Parents are requested not to enter any classroom. They are requested to contact the teachers during recess time, at the school office. Parents who seek information or want to make complaints should do so to the principal and not to the teachers
- 18. All the communications to the parents will be done through SMS, Phone calls only in case of emergency.
- 19. Parents are encouraged to respect the teachers and management. Unmannerly behavior towards teachers not encouraged.
- 20. Parents are expected to co-operate in the working of the school by enforcing regularity, punctuality and discipline and taking a daily interest in their children's progress. They should daily check the diary of their child and parent app.
- 21. Pupils who have not paid the fees will not be permitted to sit in class or to write examinations.
- 22. Violation of the regulations or conduct not in keeping with the moral tone of the school will result in the dismissal of the pupil concerned.
- 23. All the fee receipts are to be kept till the end of the academic year.

We hope and pray that the children entrusted to our care will conduct themselves to the satisfaction of all concerned and go out of the school after a successful school career as god-fearing boys and girls useful to themselves, their parents and to their country.
